


USE CAUTION

Never leave this product in the open position overnight or while away. Weather conditions causing gusting winds could result in damage to this product. If you notice excessive swaying or movement in windy conditions, close the umbrella. Under no circumstances is the manufacturer responsible for any damage caused by or to the umbrella resulting from, but not limited to, any weather-related causes.

READ BEFORE USE

Before using the umbrella, you must do the following:

- Install the chosen accessory base appropriately, according to the instructions OR
- Get four (4) 18"-20" patio stones (or similar) weighing at least 35 lbs each. Place one (1) patio stone on each of the four (4) sides of the umbrella's cross base legs. The total weight of all four (4) patio stones should be at least 140 lbs. You can use heavier stones if desired.


Before using the lighting system, you must do the following:

- 1. Insert the INPUT end of the transformer [part #118] into a 120V power supply.
- 2. Insert the OUTPUT end of the transformer [part #118] into a power socket.


- Inspect umbrella frame and all component parts before assembling. If there is any damage, take pictures and send to customer service.
- A. Umbrella Frame
- B. Vent Top Cap [part #033]
- F. Cross Base [part #100-101]
- G. Support Base [part #094]
- H. Rotating Base [part #096]
- I. Transformer w/ Power Cord [part #118]
- J. Light Globe [part #109] + Light Bulb [part #112]
- K. Cover for Rotating Base [part #095]

- 1. Install the upper cross base [F] to the lower cross base [F].
- 2. Mount the rotating base [H] to the top of the cross base with four (4) M8x30 bolts (included).
- 3. Attach the support base [G] to the rotating base with four (4) M8x20 bolts (included).
- 4. Install the vent top cap [B].
- 5. Slide the cover for the rotating base [K] over the support base.
- 6. Insert the umbrella frame [A] into the support base and tighten the thumbscrew.
- 7. Screw the light bulb [J] into the light socket, then screw onto the light globe [J].

Canopy Operation

- TO OPEN: Turn the crank [A] clockwise
- TO CLOSE: Turn the crank [A] counter-clockwise
- When storing the umbrella, use ties to secure the canopy

NOTE: When cranking, go slowly. If you feel resistance and the canopy is not opening, spread the umbrella ribs manually with your hands, then continue to crank. This will help avoid the ribs getting tangled and breaking.

• Tilt Handle Operation

- Squeeze the tilt handle [B] and move it up or down to change the angle of the canopy


Light Operation

- (--) turns the moonlight on bright and the star lights off
- (==) turns the moonlight on dim and the star lights on
- **(o)** turns the lights off

Rotating Base Operation


- Step on the foot pedal and rotate the umbrella by hand to the desired location
- Release the foot pedal to lock the umbrella in position
